\*The ordinary shares (the “Shares”) of Constellation Alpha Capital Corp., a blank check company incorporated in the British Virgin Islands (the “Issuer”), reported herein are held in the form of units (the “Units”). Each Unit consists of one ordinary share, one right and one warrant. Each right entitles the holder thereof to receive 1/10 of one ordinary share upon the Issuer’s initial business combination (“Initial Business Combination”), as described in more detail in the Issuer’s prospectus filed with the SEC on June 21, 2017 (the “Prospectus”). Each warrant entitles the holder thereof to purchase 1/2 of one ordinary share at a price of \$11.50 per share, subject to adjustment as described in the Prospectus, and each warrant will become exercisable on the later of the completion of the Initial Business Combination and 12 months from the date of the Prospectus. In accordance with Rule 13d-3(d)(1) regarding securities which represent a right to acquire an underlying security, each Unit has been reported herein as representing the beneficial ownership of one (1) ordinary share.

The Units are held by Boothbay Absolute Return Strategies LP, a Delaware limited partnership (the “Fund”), which is managed by Boothbay Fund Management, LLC, a Delaware limited liability company (the “Adviser”). The Adviser, in its capacity as the investment manager of the Fund, has the power to vote and the power to direct the disposition of all Units held by the Fund. Ari Glass is the Managing Member of the Adviser. Accordingly, for the purposes of Reg. Section 240.13d-3, the reporting persons herein may be deemed to beneficially own an aggregate of 250,400 ordinary shares, or 1.34% of the 18,530,000 ordinary shares that were issued and outstanding as of November 9, 2017, as disclosed in the Issuer’s Quarterly Report for the quarter ending September 30, 2017, as filed with the Securities and Exchange Commission on November 13, 2017.

This report shall not be deemed an admission that the Adviser, the Fund or any other person is the beneficial owner of the securities reported herein for purposes of Section 13 of the Securities Exchange Act of 1934, as amended, or for any other purpose. Each of the reporting persons herein disclaims beneficial ownership of the Shares reported herein except to the extent of the reporting person’s pecuniary interest therein.
