Each restricted stock unit represents a contingent right to receive one share of issuer common stock. Subject to the reporting person's continued service, nine thirty-sixths (9/36) of the restricted stock units shall vest on September 7, 2020 and the remaining twenty-seven thirty-sixths (27/36) shall vest in nine (9) equal installments of three thirty-sixths (3/36) on the seventh day of each third month following September 7, 2020 until the final vesting date on December 7, 2022.
